If suit is filed to enforce the payment of any sums which becomes due, the guarantor agrees to pay reasonable attorney's fees, costs of suit and interest payable at 1.5% per month.

Buyer's failure to fulfill any obligation to World Class Textiles at maturity under any contract shall accelerate and make due and payable immediately all amounts owing to World Class Textiles under that or any other contract irrespective of terms of payment expressed in such contract.
